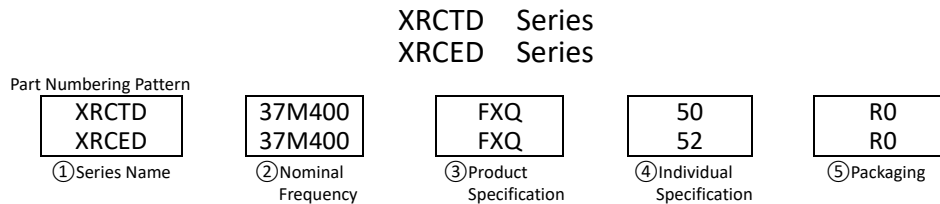


# Certificate of RoHS Compliance
